This has been an outstanding year for the Dayton VA Medical Center – outstanding for our employees, outstanding for our partners in the community, and, most importantly, outstanding for our Veterans. One of the most exciting things to happen this year was the development of a new, more effective treatment for Veterans with Hepatitis C. In response to this new treatment, the Dayton VA Medical Center increased our number of liver clinics and increased the number of medical providers treating Hepatitis C. In 2013, the Dayton VA Medical Center provided Hepatitis C treatment to six Veterans. This year, we treated 107 Veterans - a remarkable increase over just a two year period.

At the same time, this new Hepatitis C treatment is expensive – more expensive than originally anticipated. But the treatment was a priority for our Veterans, and so it was a priority for us at the Dayton VA Medical Center.

The money to cover this increased cost had to come from somewhere. Rather than ask our Veterans to sacrifice medical treatment or access – never an option – we asked our employees to make every possible cut without affecting Veteran care.

This included cutting their own overtime, retention bonuses, and recruitment incentives. Our employees across the board sacrificed so our Veterans would not have to – an outstanding dedication to our “Relationship Based Care” principles. Thanks to our employees’ sacrifice, a projected six million dollar deficit turned into a surplus in just five months.

Yet even during this time of sacrifice, the Dayton VA Medical Center leads the state of Ohio in employee satisfaction, with the highest overall satisfaction scores in the entire VISN. Employee burnout is the lowest in the VISN. And our customer satisfaction levels are the highest they’ve been in years.

This has also been an outstanding year for Veteran engagement. We’ve now held Veteran listening sessions at the Dayton VA Medical Center and all of our Community Based Outpatient Clinics (CBOCs). These listening sessions are open to all Veterans, members of the public, and the media. Everyone gets the chance to speak, ask questions, seek assistance, or provide feedback directly to our leadership team. This

ensures 100% transparency and accountability – a vital aspect of the trust that we have established in our community and with our Veterans.

In the same spirit, this has been an outstanding year for engagement with our community partners. We have a sharing agreement with Wright Patterson Air Force Base which increases medical care access for our Veterans while simultaneously helping Wright Patterson’s medical team keep their skills sharp, improving war readiness. This sharing agreement began in May of 2015 with 20 referrals a month. By November of 2015, we reached 200 referrals a month.

We’ve also teamed with the St. Mary Development Corporation and other organizations to open Lyons Place II – a high-quality assisted living facility for low income Veterans, directly across the street from our medical tower.

These new partnerships are launching just as we reach simultaneous new heights in innovation. I am proud to announce the Dayton VA Medical Center has installed a brand new, state-of-the-art MRI/CT facility. This new equipment will assist with gathering better MRI and CT imagery of our Veterans – especially those with claustrophobia and other PTSD symptoms.


This has truly been a remarkable year for the Dayton VA Medical Center.

- Social Work collected 1,793 pounds of peanut butter in the month of March for local food pantries. This exceeded last year's donated amount of peanut butter (193 pounds) by 829%!

- Unveiled Lyons Place II, an enhanced use lease partnership with St. Mary Development Corporation, housing for low-income seniors.
- Partnered with Dayton Area Koreans Association and Korean Veterans Memorial Association to host ceremony honoring our Korean Veterans.
- Successfully hosted Secretary Bob McDonald visit, discussed wait times, construction projects, and potential for Dayton VA Medical Center to become host of National VA Archive.
- Richmond CBOC honored with Wayne County Chamber of Commerce "Quality of Life" Community Improvement Award.
- Worked with Emmy-award winning actor Bryan Cranston and TLC's "Who Do You Think You Are" to highlight historical importance of the Dayton VA Medical Center.
- Initiated joint sharing agreements with Wright Patterson AFB to improve provider access for our Veterans.
- Teamed with the Dayton Dragons and Fifth Third Field to host our 8th annual Welcome Home Event. We hosted 100 OEF/OIF/OND Veterans and their family members, plus 200 Vietnam Veterans in recognition of the 50th anniversary of the Vietnam War. Purple heart recipients were honored during the game with a shadow box containing a flag flown over the US Capitol and certificates of appreciation.

# Construction & Innovation...

- Completed construction of a new CBOC in Richmond, Indiana. The new CBOC is nearly twice the size of the previous clinic, and offers all of the services previously provided plus an additional PACT team and new physical therapy services.
- As the Pilot facility for VISN 10, Human Resource Management Service successfully introduced and provided training for the new ePerformance Program.
- Opened new simulation center, featuring state of the art medical training technology such as mannequins that sweat and bleed. This is the largest simulation center in the region.
- Renovated third floor to offer private rooms in medical/surgical unit.
- Installed visual messaging system throughout Dayton VA Medical Center and CBOCs – will assist in increasing communication with staff, Veterans, and visitors.

- Employment specialists obtained 45 permanent job placements for Veterans with a living wage of \$16-\$18 per hour.


